




5. Spur Hill Coking Coal Project

Spur Hill Coking Coal Project – work program for next 5 years

- Application for renewal of EL7429 for a further 5
 years was lodged in October 2019 with NSW
 Department of Planning, Industry and Environment
 (DPIE) Division of Resources and Geoscience.
- The future exploration program is designed to enhance the understanding of the geological interface between EL7429 and EL5460.
- The work program will also provide data to review the previously completed Prefeasibility Study and determine the options for accessing the deposit from the east rather than the previously proposed access in the northwest.







6. Maxwell Infrastructure

Maxwell Infrastructure Rehabilitation

- ✓ Approximately 90ha of rehabilitation complete in 2019 against a target of 86ha.
- Completed a spring weed spraying program.
- Completed a spring tree planting program.
- Undertaken dog trapping on site.
- Introduced cattle to the east paddock.
- ✓ There are now more than 700 hectares of rehabilitated pasture and woodland.








Grazing Trial Update




- Cattle movements:
 - 7 heifers moved onto site.
 - 42 steers (weighing c. 500kg) removed off site to be finished off on sorghum.
- Resting rehabilitation paddocks over summer and monitoring species diversity.
- New growth coming up after recent rainfall.
















7. Maxwell Underground Project

Maxwell Underground Project EIS update





The public exhibition concluded on 24 September 2019.

- The DPIE received 245 submissions 187 from the community, 44 from organisations, and 14 from government agencies.
- Malabar was pleased with the strong endorsement of our Project, with c. 75% of submissions in support.
- Community confidence in the Project recognises the many and real benefits the Maxwell Underground Project offers and the long-term engagement we have had with our communities.
- We will continue engaging and listening to the community through the DA process and through the life of the Maxwell Underground Project.


Our "Response to Submissions (RTS)" reports was lodged on 20 November 2019.



8. Maxwell Solar Farm

Maxwell Solar Farm Approval Process



BAYSWATER POWER STATION



Malabar has submitted a Development Application for the Maxwell Solar Farm

- The solar farm will occupy approximately 105ha of previously rehabilitated areas.
- Adjacent to the major electricity generating hub in NSW (Liddell ad Bayswater Power Stations) and in proximity to high voltage power lines.
- Installed capacity of 25MW.
- The solar farm would generate enough energy to power about 10,000 local homes.
- EIS & DA lodged in December 2019 and closed for submissions on 3 February 2020.
 - No objections.








Long Term Community Contributions Fund


