


5. Spur Hill Coking Coal Project

Project Update

- In January 2021, Malabar submitted the annual activity report for EL7429 in accordance with the Exploration Guideline: Annual Activity Reporting for Prospecting Titles (NSW Department of Planning, Industry and Environment).
- Year 2 of the current work program for EL7429 focusses on a 2D seismic exploration program to better understand the resource.









Community Consultative Committees

- Malabar Resources has the following CCC's:
 - Spur Hill CCC Spur Hill Underground
 - Maxwell Infrastructure CCC Maxwell Infrastructure site
 - Antiene CCC Joint CCC with BHP focussing on the Antiene Rail Spur
 - A requirement to establish a new CCC for the Maxwell UG Project under SSD 9526.
- Malabar are seeking to combine CCC's to:
 - Streamline information provided to the community.
 - Provide consistent information across all projects.
 - Provide CCC members with an update across all projects and our long term strategy.





Community Consultative Committees

- Malabar Resources is proposing to combine and reduce the number of CCC's to the following:
 - Combined Maxwell and Spur Hill CCC this will cover the recently approved Maxwell UG Project (which incorporates Maxwell Infrastructure) and Spur Hill Underground (EL 7429)
 - Antiene CCC Joint CCC with BHP focussing on the Antiene Rail Spur.
- The CCC would be established in accordance with the DPIE's Community Consultative Committee Guidelines: State Significant Projects.
- All existing members would be encouraged to apply.
- We would invite Coolmore and Godolphin horse studs to be part of the combined Maxwell and Spur Hill CCC.
- CCC meetings would continue on a quarterly basis.
- The venue and meeting time to be discussed with both CCC's.





6. Maxwell Underground Project



- On 22 December 2020, the NSW Independent Planning Commission approved the development application for the Maxwell Underground Coal Mine Project (SSD 9526), in accordance with Part 4 of the Environmental Planning and Assessment Act 1979 (the Act).
- The determination follows the project's comprehensive and technical review by independent experts and rigorous assessment by the NSW Department of Planning, Industry and Environment (Department).
- The Department in its whole-of-government assessment report released in October 2020 concluded that the Maxwell Underground Project was "in the public interest" and "approvable."

Development Consent

Section 4.36 of the Environmental Planning and Assessment Act 1979

7. Maxwell Infrastructure

Rehabilitation Activities

- Approximately 32 hectares of land was prepared for planting.
- ▶ 36,000 plants were planted.
- Follow-up watering to take place.
- Weed spraying continued.
- Wild dog trapping continued on buffer land.
- 20 nest boxes installed on rehabilitation
- Annual Ecological monitoring undertaken.









- Grazing trial to continue in 2021 to improve species diversity as we work towards creating a landform that is compatible with the surrounding landscape and capable of a productive land use.
- Malabar are working with a local farmer from the Denman area.
- 17 steers arrived on site in December 2020.













- Action DM to provide a summary of the spike that occurred in mid August 2020.
- There was a spike in the 24hour average PM₁₀ on the 19th of August.
- This coincided with a southerly front that moved across NSW. Dust levels were elevated across the Hunter Valley on this day.
- Wind was predominantly from the North West and this monitor was downwind of the Maxwell Infrastructure site for 1 per cent of the day.

PCYC Humble Homes



- In October, Malabar donates \$1000 towards the PCYC Humble Homes Program which helps to rehome local families relocating from domestic violence situations and provides housing services for homeless youth under 25.
