ACTIVITIES FOR THE QUARTER ENDED 31 DECEMBER 2023

Construction and operational highlights for the quarter include:

Access road and MEA:

Access Road and Overland Conveyor corridors substantially advanced including commencement of bitumen seal.

Bord & Pillar operation:

- * "New to Industry" program launched to address labour supply shortages in the market
- * 1st low height continuous miner commenced in November with second low height continuous miner expected to commence in February 2024
- * Place change panel operation commenced in November with second panel to commence in February 2024



Longwall operation:

- * Surface to seam "declines" drivage continues
- * Longwall equipment manufacture progresses on schedule with ZMJ in China, HBT in Europe, and Ampcontrol in Australia

Coal Sales:

Spur Hill Underground Project (EL 7429)

A seismic program to better define a geological feature called the "Eastern Boundary Fault" which separates the Maxwell resources from those in Spur Hill EL 7429 was completed in November, with rehabilitation of surface disturbance commencing shortly afterwards. Data is currently being reviewed to assess next steps.

Environment

Quarterly activities include:

- * Land management activities were undertaken such as weed spraying and feral animal management on site and within our offset areas.
- * Spring tree planting program completed with over 5,500 trees planted.

ESTABLISHMENT OF A BIODIVERSITY STEWARDSHIP SITE

In December Malabar received approval for the establishment of a bio-diversity stewardship site which is a permanent conservation site that protects the habitat for native species and ecosystems. This is another indication of Malabar's commitment to being a responsible custodian of the land and environment that we operate within.

MAXWELL SOLAR FARM

The Maxwell Solar Farm is an approved 25 megawatt (MW) solar farm, to be constructed on land we have rehabilitated from past open cut mining operations.

Malabar has selected a power supplier to provide a whole-of-mine solution involving the Maxwell Solar Farm "behind-the-meter" supplemented with grid supply.

The preferred supplier is currently undertaking technical work to firm their proposal.

EDDERTON SOLAR FARM

The EDF Renewables and Malabar joint venture is developing the Edderton Solar Farm and large-scale Battery Energy Storage System (BESS) in the Hunter-Central Coast Renewable Energy Zone (REZ).

The Edderton Solar Farm will have a capacity of around 350MW and will sit on approximately 1,000 hectares with a provision for a large-scale battery storage facility.

Community drop-in sessions are currently being held to the provide community members an opportunity to meet the team, view the project information, draft maps and share their thoughts on factors that should be taken into account as the project progresses.
